
**NOTICE OF PLAINTIFFS' MOTION FOR A PRELIMINARY INJUNCTION**

**PLEASE TAKE NOTICE** that, upon the accompanying Memorandum of Law,  
Declarations of Morris Tuchman, Clinton Greenbaum, Marvin Tenzer, Alan H. Schechter, Carol  
Schechter, Rabbi Peretz Steinberg, William J. Balcerski, Michele A. Pincus, Robert G.

Sugarman, and the Exhibits thereto, plaintiffs EAST END ERUV ASSOCIATION, INC., MARVIN TENZER, MORRIS TUCHMAN, CLINTON GREENBAUM, ALAN H. SCHECHTER, and CAROL SCHECHTER (collectively, "Plaintiffs") will move this court for an order pursuant to Rule 65 of the Federal Rules of Civil Procedure granting a preliminary injunction enjoining defendants THE VILLAGE OF WESTHAMPTON BEACH, CONRAD TELLER, individually and in his official capacity as Mayor of the Village of Westhampton Beach, TONI-JO BIRK, LEOLA FARRELL, JOAN S. - (b) continuing to engage in discriminatory and unconstitutional conduct against Plaintiffs.
