RE: 2019 VILLAGE BEACH PERMITS

As a commercial property owner in the Village of Westhampton Beach, I am writing to inform you of the regulations as they relate to the issuance of beach permits and passes.

Non-owner occupied commercial property owners are entitled to two (2) complimentary parking stickers and four (4) walk-on passes. If you chose, you are permitted to give any or all of the stickers and/or passes to your building tenants for their personal use only, so long as you inform the Village in writing.

Enclosed, you will find a form that you must file with the Clerk's office indicating whether or not you would like to retain your stickers and passes or if you would like to assign them to your tenant(s).
